## WHAT IS AFI DATA PORTAL (ADP)?

---

The ADP is a unique and integrated global database on financial inclusion policies, regulations, and outcomes, that is built by policymakers for the benefit of policymakers and the public. Housing information sourced directly from policymakers and regulators, the ADP empowers countries to share their financial inclusion stories through data.

The ADP responds to the members' increasing demand for online space to access and share financial inclusion data, complementary to other AFI services.

- > For policymakers and regulators, the Portal gives opportunities to deepen peer learning.
- > For development practitioners and other stakeholders, it offers access to essential insights on the countries' current status and next steps on financial inclusion policies and regulations.

The ADP is open for access to anyone, free of charge.

## WHICH DATASETS ARE FEATURED IN THE ADP?

The ADP currently features three datasets:

- > **Maya Declaration Commitments**, which are the world's first commitment platform under which AFI member institutions publicly pledge concrete financial inclusion targets and regularly report progress towards achieving them. Through the Portal, users can view all Maya Declaration commitments and related progress reports. AFI members can also announce new Maya Declaration targets and submit progress reports on existing ones.
- > **AFI Country Policy Profiles**, which is the first repository of knowledge containing information on the legal and regulatory status of financial inclusion in each country. The Profiles allows users to examine regulatory frameworks of each country as well as to identify thematic, regional, and global trends.
- > **Financial Inclusion Indicators**, which comprises AFI Indicators as well as country-specific indicators. In addition, AFI members can add their own indicators, report value on existing ones, and view other countries' indicator data.

- > Raise your countries' public profiles on financial inclusion achievement
- > Download primary legal and policy documents on financial inclusion
- > Identify countries with with advanced financial inclusion policy frameworks or with successful financial inclusion outcome
- > Learn how other countries' policymakers/regulators measure financial inclusion
- > Define your national goals and targets based on Maya Declaration Commitments by peers facing similar financial inclusion challenges

### BENEFIT FOR OTHER STAKEHOLDERS

- > Gain insights on countries' regulators priorities and needs on financial inclusion to align your resources to these needs
- > Gain access to alternative sources of financial inclusion data sourced directly from policymakers and regulators, in complementary to other global database
